Dave Williams, the advisor to the Minister on CAMHS, introduced an outline of the days programme. *The NHS Wales Peer Review Framework: July 2017* makes clear the Welsh Government mandated requirements on peer review in Wales. This event will form the way we roll out peer review to CAMHS teams in Wales with overall design and support by the network. The process however is to be 'owned' individually by each of the seven health boards in Wales.

The event aimed to inform all who attended of the overall governance framework within which a national programme of clinical peer review will be managed within NHS Wales and will build on the learning from existing schemes already developed in cancer and critical care.

For the next part of the programme delegates provided answers and responses to 3 key questions as illustrated below:

Q1: Better engagement; review of DNA policies; flexible YP friendly locations; integrated co-production of outcome focussed plans; a range of quality therapies across all modalities; staff training and team dynamics; what about the ND and ASD gap!; consolidation of current reviews; ED, CRISIS, PCAMHS; empowering the team to do clinical peer review; staff well-being and safety; collaborative approach with a strategic longer term view; no quick fix; include perinatal services.

Q2: Highest level of commitment required across all organisations; systems, processes, governance, IT structure; 'we're all in it together'; no isolated partners; better use of technology; dedicated time for staff to train; HB to determine baseline requirements; CAPA implementation; Regional V local provision; 3rd sector and wider partnership working; take account of existing national all Wales reviews.

Q3: Resources dependant; training required; lack of capacity already exists; potential weakening of existing services; resistance to change from staff; reaction from teams to review findings; political change; performance management to be implemented as a result of peer review; dissolution that it might not make a difference; awareness raising required.









Next Steps

On May 14th we have planned a training day on the design, development of standards and roll out of clinical peer review programme and timetable for CAMHS in Wales. The day's programme will consist of:

- Training in the peer review process to be implemented;
- Finalising the clinical peer review teams from each health board in Wales;
- Work with health board's clinical peer review teams to agree, design and set the standards to be reviewed;
- Inform health boards of the timetable of dates for site visits throughout 2019–2020.
